Based in Brussels, we currently have seven member organisations in Austria, Belgium, Estonia, France, Germany, the Netherlands and Sweden. They represent more than 3,000 green companies, most of them small and medium-sized enterprises (SMEs).

ecopreneur.eu is recognised by politicians and the EU administration as an important partner for bringing alternative, future-oriented input into the debate.
